#### ROUNDTABLE ON CIVIL STATUS REGISTRATION IN NORTH MITROVICA (FEBRUARY 26, 2025)


ACDC hosted a roundtable to discuss the challenges surrounding civil registration following the recent decision by the Kosovo Ministry of Internal Affairs (MIA). This policy allows Kosovo citizens who have only Serbian documents to register in the Kosovo system by April 30, 2025. However, participants raised concerns about bureaucratic obstacles, unclear procedures, and inconsistencies in implementation. The discussion underscored the importance of transparent procedures and improved public awareness to ensure all citizens can exercise their civil rights.

#### ROUNDTABLE ON HUMAN RIGHTS IN PEJA/PEĆ (FEBRUARY 19, 2025)

In collaboration with the Ombudsperson institution, ACDC facilitated a discussion with the Ombudsperson, civil society organizations, and citizens on human rights, focusing on access to justice and institutional accountability.



#### **NEW CYCLE OF YOUTH CAMPS KICK OFF IN PRIZREN (FEBRUARY 21-23, 2025)** Our first youth camp of 2025 gathered young people from diverse communities to strengthen language skills, cultural exchange, and mutual understanding. Through interactive VOCUP methodology, participants engaged in teamwork exercises and social games while also exploring Prizren's rich cultural heritage. This initiative is part of the YESS project, implemented by IOM Kosovo and UNICEF.



#### SEMINAR ON MINORITY RIGHTS AND INCLUSION

ACDC organized a working seminar from February 25-27 in Durrës/Albania, focusing on strengthening the rights of non-majority communities through legislative and policy development. The seminar brought together representatives from institutions, including the Deputy Prime Minister, Ministry for Return and Communities, Prime Minister's Adviser for Communities, Office for Communities, Office for Good Governance, Ombudsperson Institution, and civil society representing

the Serbian community to analyze legal frameworks and develop recommendations to improve inclusion and equal rights.

#### NEW PROJECTS LAUNCHED

Stage of Integrity – Theater Against Corruption: This project will use performing arts as a tool to raise awareness and spark discussions on corruption in Kosovo, fostering civic engagement through creative expression.

Youth in the Legal Sector: ACDC is launching a career-building initiative for young legal professionals, providing mentorship, training, and networking opportunities to strengthen the legal sector.

#### PRESS RELEASE

The NGO Coalition Democracy in Action published a statement after the elections, highlighting concerns about the delays in vote counting and their impact on public trust. 


